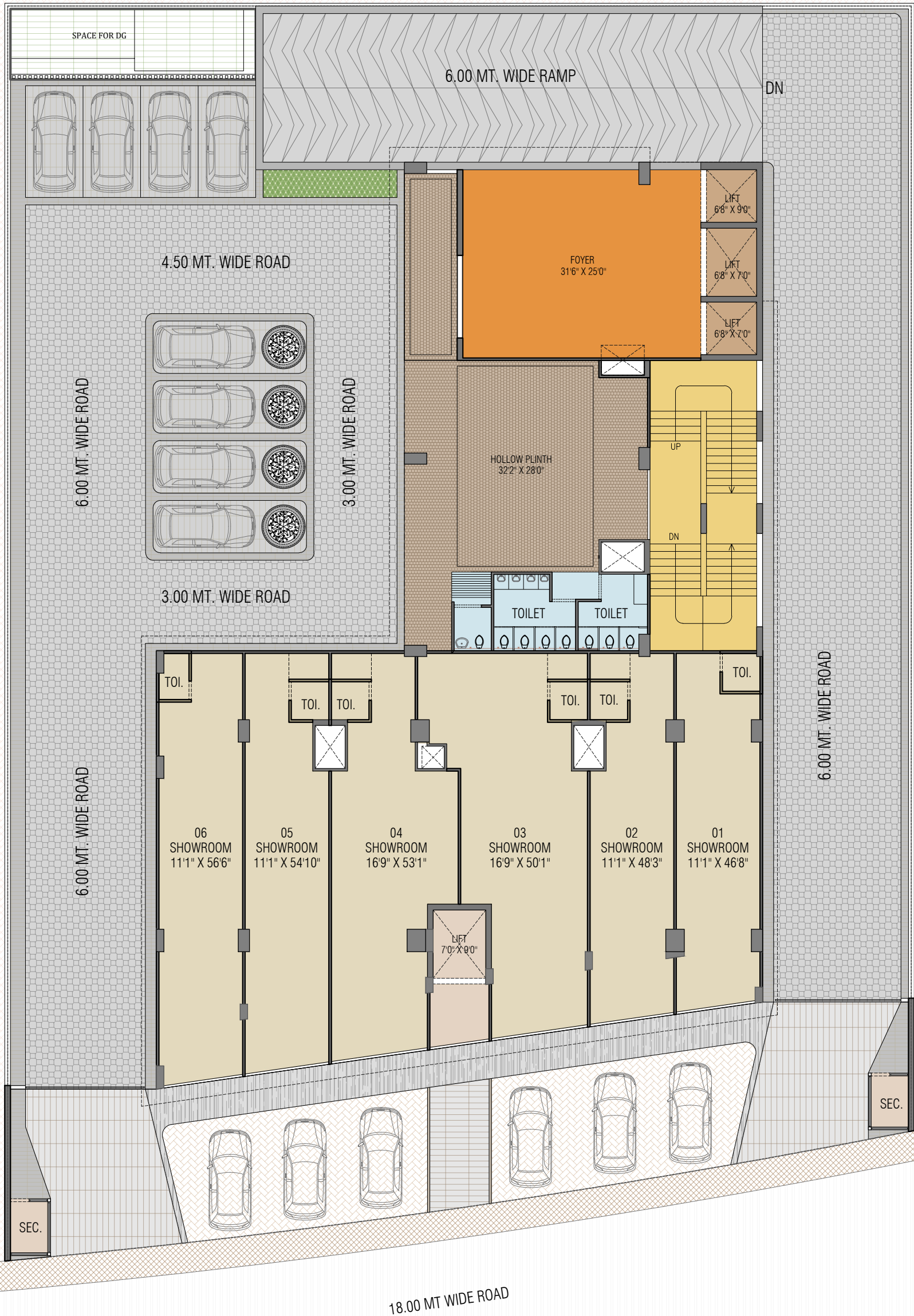

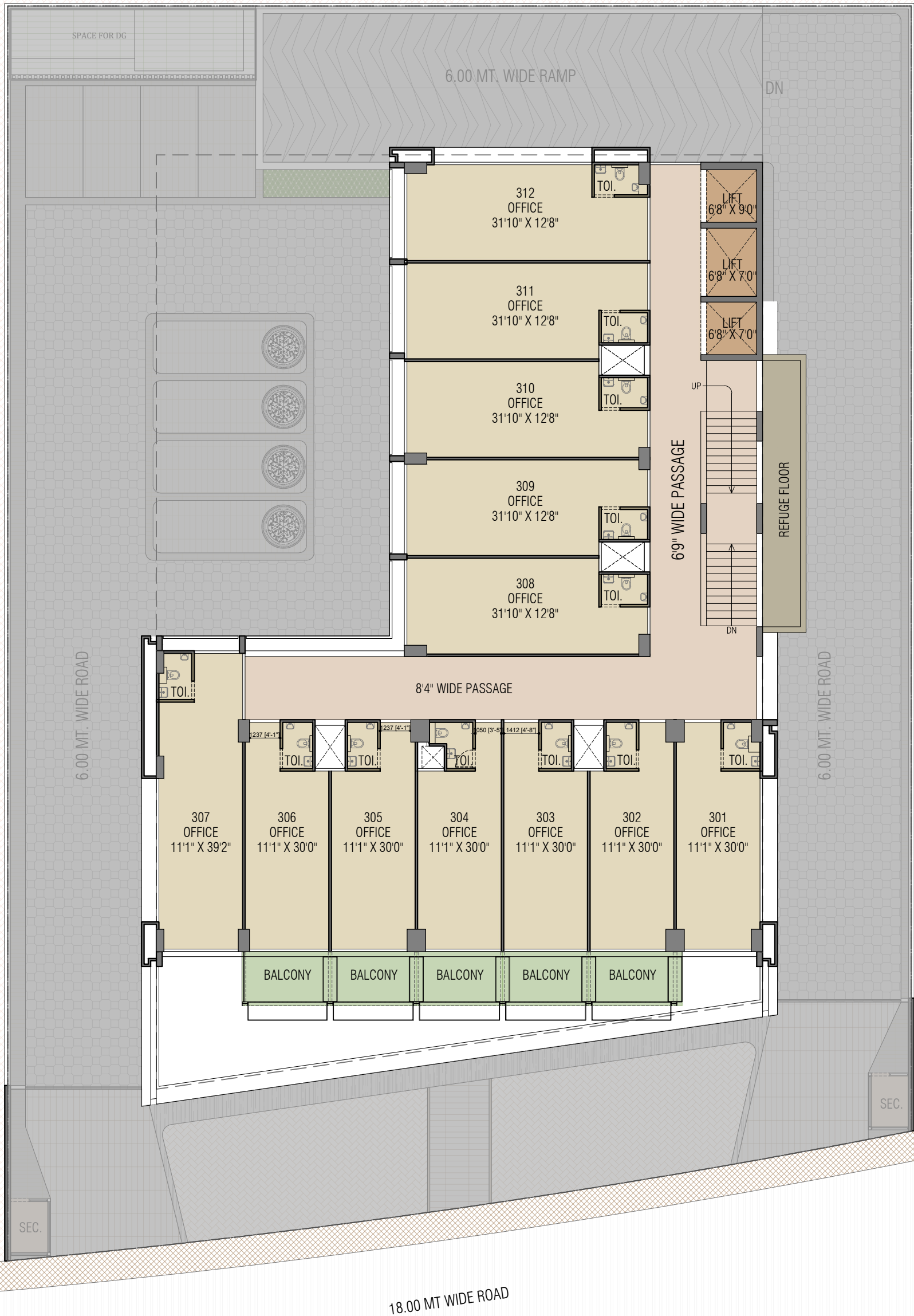


3RD FLOOR PLAN

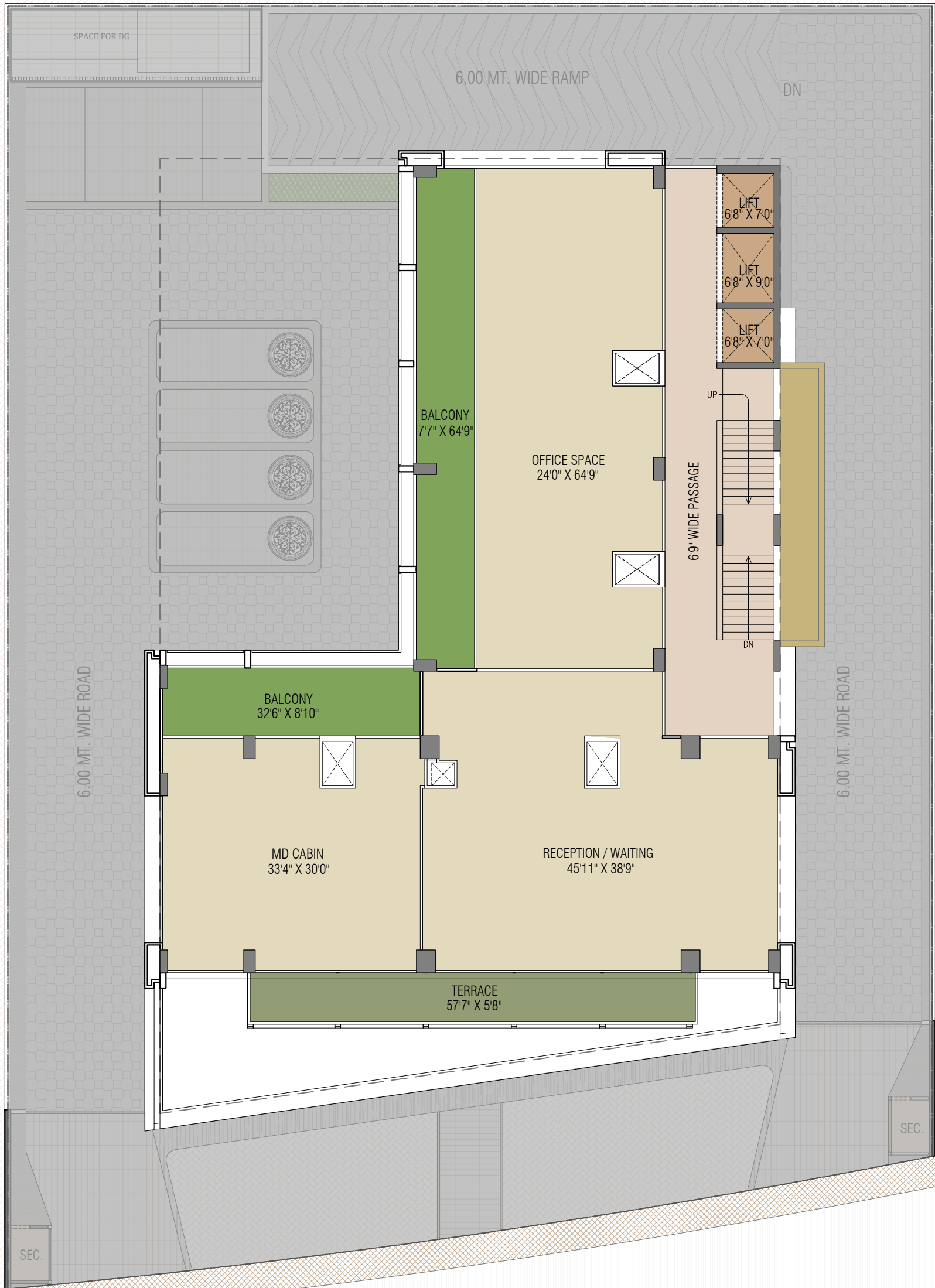
